 DC/17/05732 Street Farm The Street Framsden: Application for Listed Building Consent. Replacement of 4no. front windows.

After discussion, the Parish Council agreed the following decision: No objections, hence implied support.

 DC/18/00084 Moat Farm Birds Lane Framsden: Householder Planning Application - Erection of single storey extension with flue and link structure to east elevation (following demolition of existing porch and outbuilding). Erection of garden shed, relocation of oil tank and new opening in garden wall. Installation of woodburner and flue.

Councillors comments in discussion included a view that the design, which would be visible from the road, contrasted with the farm house, which is an historic building.

The Parish Council agreed the following decision:

The Parish Council agreed the following decision:

To object to the application which was viewed as being detrimental to an historic building.

 DC/18/00085 Moat Farm Birds Lane Framsden: Application for Listed Building Consent. Erection of single storey extension and link structure to east elevation

Council agreed that the Heritage Team may have a different view, but FPC think this would be detrimental to grant Listed Building Consent.

• DC/18/00100 Dobermann Inn The Street Framsden: Change of use from a public house (A4) to residential (C3).

Councillors views expressed included the following points. There would be a loss of amenity and the application would be contrary to national and local (MSDC) planning policies, including the National Planning Policy Framework which specifically mentions public houses. FPC supports the current ACV listing having previously submitted its own ACV nomination, which was initially successful, and supports retention of the pub. Planning guidance criteria for the proposed "Change of Use" are not met. It is viewed that the application does not make a case that the "Change of Use" would benefit the village. There was no support given to the application from councillors.

CM and GB chose to abstain from voting.

Decision: Council agreed to object to the application based on all of the above points.
